- 1) The following City of Wisconsin Rapids law enforcement, fire, and emergency personnel shall be required to reside within 30 miles of the boundaries of the City of Wisconsin Rapids within 12 months of their date of hire, or within the time limit set forth in said employee's employment agreement.
 - a) All sworn Fire Department personnel
 - b) All sworn Police Department personnel
 - c) The following Department of Public Works personnel:
 - i) Park and Buildings Supervisor
 - ii) Public Works Director
 - iii) Public Works Superintendent
 - d) The following Water Works and Lighting Commission personnel:
 - i) Electrical Superintendent
 - ii) Linemen
 - iii) Meter Service Techs
 - iv) Water Superintendent
 - v) Water Service Techs
- 2) All employees in section (1) above shall be required, as a condition of their employment, to continue to reside within 30 miles of the boundaries of the City of Wisconsin Rapids as long as they remain employed by the city.
- 3) City of Wisconsin Rapids employees shall abide by any state statutes that require residency within the jurisdictional limits of the City of Wisconsin Rapids or any provision of state or local law that requires residency in the State of Wisconsin.
