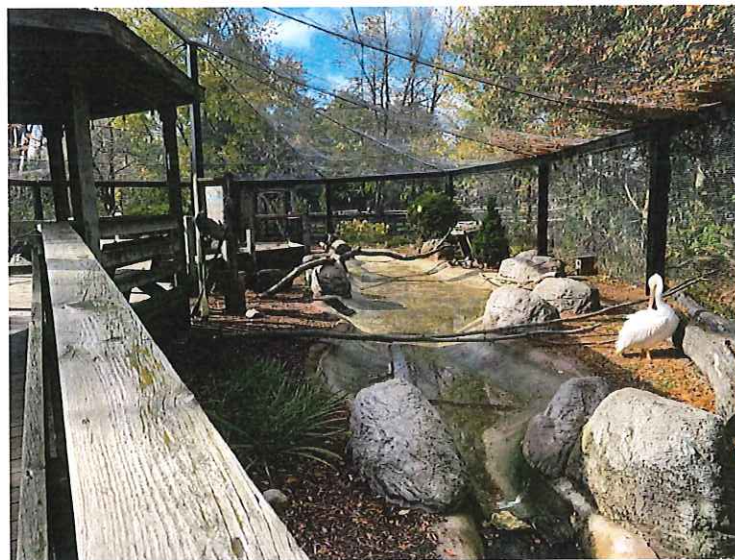
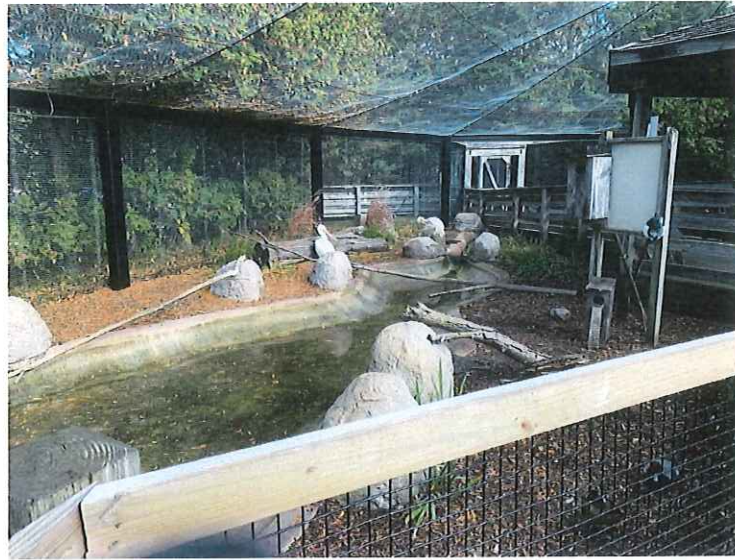

DOG PARK RULES

1. Hours are Sunrise to Sunset.
2. All dog(s) must be licensed and vaccinated according to your veterinarian's recommendations, including the City's required Rabies vaccination. All dogs are required to be current with rabies vaccination in accordance with Wisconsin State Statute 174. Proof of a current rabies vaccination and license is required upon request of a police or animal control officer. Tags may serve as proof.
3. Dogs must be leashed when entering and exiting the Dog Park.
4. For the safety of your dog(s) and other park visitors, choke, prong (pinch) and spike collars are strictly prohibited. If you use these types of collars, remove them before entering the park.
5. No children under the age of 16 are allowed unless accompanied by an adult. Children have a tendency to scream and run when excited, which can trigger a dog's prey drive or natural instinct to chase. For this reason and for the safety of your children, we do not recommend bringing small children or infants into the dog park.
6. Inappropriate or aggressive behavior will not be tolerated and may be subject to fines. If your dog becomes unruly and plays too rough, or shows any sign of aggression, we ask that you please leash it and leave immediately. Report incidents to the Wisconsin Rapids Police Department. Non-emergency phone is: (715) 423-4444.
7. Dog(s) in heat, sick (vomiting, diarrhea, cough), with fleas, or under four months of age are prohibited from entering the park.
8. Dog owners must be in the park and within view of their dogs at all times.
9. All off-leash dogs must be under voice control of their owners. If you cannot control your dog off leash, keep your pet leashed at all times.
10. Dog owners must keep their leash in hand at all times.
11. Please leave all food, treats and dog toys at home.
12. Owner must pick up and dispose of dog's waste in the receptacles provided. Waste bags are provided for your convenience throughout the park.
13. Fill any holes your dog digs.
14. Report a bite or scratch to the County Health Officer or a physician within 12 hours.
15. Close and latch all gates behind you. Call your dog(s) away from the gate while others are entering and leaving.
16. Failure to abide by the park rules may result in loss of privileges or a fine to owners.
