February was a very diverse month beginning with our annual Hazardous Materials Physicals. As a State Type III Haz Mat team we are mandated to conduct physicals for all members of the Haz Mat team. This used to be a much larger cost prior to contracting with Med Compass last year. Cost prior to then was \$22,000. The last two years the contract for the same physicals has been \$12,000. Great initial savings and logistical savings in Overtime and time spent while on duty not available to count to staff. Med Compass also focuses on Emergency services for these physicals, so they focus on the most significant aspects of our industry when completing these physicals. What used to take all month to complete can now be done in four days.

Staying in focus with Hazardous Materials, the month of February also found two Subject Matter Experts (SME) from the Regional All Climate Training Center (REACI) in house for an all-day training with each crew on Hazardous Materials response. This training was made possible by a grant that Battalion Chief Kubis wrote to the REACT center which paid for the training. Each crew spent 8 hours with the SME's reviewing our target hazard chemicals and transportation of those chemicals in the morning followed by an afternoon of hands-on training using the newest devices in the industry for mitigation of these responses. As a State Type III team, we are required to complete 8 hours of continuing education every year in this category. This training is not the only training we do in a year in this subject, we try to review some type of Special Operations response every quarter.

Training is a top priority in the Fire Industry and that is no different at WRFD Every afternoon, even when interrupted by many calls, the crews train on a vast array of response disciplines. This month we focused on Wildland Fire Response. We do not do a lot of Wild Land Response in the city, but are many times requested to respond out of the city to help our mutual aid partners. Members of the DNR lead an afternoon of training with each of the crews throughout the month. That training consisted of wildland fire response tactics, as well as using the plotted map books the DNR has produced that sector off the entire county into manageable regions to mitigate this type of incident. The afternoon was then spent with scenarios using the training they received with the plot books and developing an incident action plan to extinguish the simulated fire.
