Controlled Substance Arrests

Wisconsin Rapids Police Officers and Detectives made **31 arrests** for Controlled Substance offenses in August 2022. These charges include:

- Possession of Narcotic drugs.
- Possession of Methamphetamine.
- Possession of Drug Paraphernalia.
- Manufacture/Deliver THC
- Possession of illegally obtained prescription

Notable investigations and arrests:

08/16/2022, Complaint 22-12417

On August 16, 2022, Officer Brockman and other officers were dispatched to 1150 19th Ave S for a report of a disturbance. The male and female left the address in a black Mazda. Officer Brockman located the black Mazda and made a traffic stop on the vehicle. The female passenger was seen trying to stash a bag of ecstasy within the vehicle. Officers conducted a search of the vehicle and located a bag of THC, digital scale, and Methamphetamine. The male driver had a bag of brown powder material in his shorts that was later found to be fentanyl. The male passenger also tried to hide methamphetamine in the back of the squad car while traveling to the jail. A total of 87 grams of methamphetamine, 10.08 grams of THC, 9 grams of ecstasy, and 10.3 grams of fentanyl were located.

One subject was charged with possession of marijuana, Possession of MDMA, Possession of methamphetamine, and resist obstruct an officer

One subject was charged with Possession with intent to deliver methamphetamine, possession of fentanyl, and possession of drug paraphernalia
