Mayor Vruwink requested that all present stand for the Pledge of Allegiance and a moment of silent prayer.

Mayor Vruwink explained that people in the audience may be able to address the Council, but only regarding items on the agenda and only if recognized by an alderperson.

- 5. Reading of the Minutes of the Previous Meeting held on December 17, 2019 It was moved by Koth, seconded by Kellogg to dispense with a reading and accept the minutes of the previous meeting. Motion carried, 6 ayes and 1 nay with Kubisiak voting in the negative.
- 6. Mayor Vruwink's Report

Motion by Rayome to accept the Strand proposal for design services for West Jackson Street, DOT project ID 6999-11-08/78 between West Riverview Expressway and the Jackson Street Bridge. There was no second.

Motion by Kubisiak to accept the Quest proposal for design services for West Jackson Street, DOT project ID 6999-11-08/78 between West Riverview Expressway and the Jackson Street Bridge. There was no second.

- 1. Chairperson Blaser called the meeting to order at 4:46 p.m.
- Review the current Assessment Technician position and consider modifications thereto as a result of an upcoming retirement; consider and approve a position description and compensation for the position if modified.

Motion by Zurfluh, second by Blaser, to approve the Administrative Technician job description as presented, with the change "will assist the permitting process and support other Community Development Department activities." This will be a 40 hour per week position, with compensation at Grade 5. Motion carried, 2-0. (See attached job description)

3. Consider a change to the Sick and Paid Leave policy, removing the requirement that an employee must use one week of sick leave or other paid leave before the City provides paid leave for a second week of family member leave.

Motion by Blaser, second by Zurfluh, to go into closed session pursuant to Section 19.85(1)(c) of the Wisconsin Statutes, which reads: "Considering employment, promotion, compensation, or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility." Roll call vote taken. Both members voted in the affirmative. Motion carried, 2-0.
  - a. In closed session, the Committee discussed compensation and benefits for an employee.
  - b. Motion by Zurfluh, second by Blaser, to return to open session. Motion carried, 2-0.
- 6. Motion by Zurfluh, second by Blaser, to make no changes to the compensation for the employee. Motion carried, 2-0.
- 7. Motion by Zurfluh, second by Blaser, to go into closed session under Section 19.85(1)(e) of the

Wisconsin Statutes, which reads: "Deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session". Roll call vote taken. Both members voted in the affirmative. Motion carried, 2-0.

- a. In closed session the committee received an update and discussed strategy regarding negotiations and possible interest arbitration with International Association of Firefighters Local 425.
- 8. Motion by Zurfluh, second by Blaser, to adjourn in closed session. Motion carried, 2-0. Meeting adjourned at 6:03 p.m.

Roll call vote was taken and the motion carried, 5 ayes and 2 nays with Kubisiak and Blaser voting in the negative. Alderperson Kubisiak left the meeting at this point.

- a. In closed session, the Council reviewed and considered approval of design services for the design of West Jackson Street (DOT project ID 699911-08/78) between West Riverview Expressway and Jackson St Bridge.
- b. It was moved by Koth, seconded by Blaser to return to open session. Motion carried, 5 ayes and 1 nay with Verjinsky voting in the negative.

It was moved by Koth, seconded by Kellogg to award the contract for design services to Strand for the design of West Jackson Street (DOT project ID 699911-08/78) between West Riverview Expressway and Jackson St Bridge, however if the contract is materially different than the proposal, Council approval will be required. Motion carried, 4 ayes and 2 nays with Verjinsky and Blaser voting in the negative.

It was moved by Koth, seconded by Blaser to adjourn. Motion carried 7 ayes and 0 nays, and the meeting adjourned at 8:00 p.m.
