#### 4.01 VOTING DISTRICTS.

- (1) Pursuant to Section 62.08(1) of the Wisconsin Statutes, Wisconsin Rapids' wards, as defined in Section 4.06 of the Municipal Code, shall be combined into aldermanic districts as follows: (MC#1128)
- (a) Aldermanic District #1 shall consist of Wards 1 and 4.
  - (b) Aldermanic District #2 shall consist of Wards 2 and 3.
  - (c) Aldermanic District #3 shall consist of Wards 5, 6, 22, and 23.
  - (d) Aldermanic District #4 shall consist of Wards 10, 12, 24, and 28.
  - (e) Aldermanic District #5 shall consist of Wards 7, 8, and 9.
  - (f) Aldermanic District #6 shall consist of Wards 11, 13, 14, 26, 27, and 29.
  - (g) Aldermanic District #7 shall consist of Wards 18, 19, 20, and 21.
  - (h) Aldermanic District #8 shall consist of Wards 15, 16, 17, and 25.
- (2) Areas annexed to the city after passage of this ordinance shall be assigned by ward to the nearest contiguous aldermanic district as part of the appropriate annexation ordinance.
- (3) Combining Wards. To accommodate administration of individual elections, the city clerk is hereby granted the authority to combine wards as necessary.

#### 4.02 ELECTION BOARD.

At the regular council meeting in December of each even-numbered year, the mayor shall nominate persons for an election board for each of the election voting districts for the City of Wisconsin Rapids. Each such board shall consist of inspectors of election. The number per district shall be determined as necessary by the city clerk to adequately staff each election. The council shall immediately approve or disapprove such nominations. If they disapprove any such nominee, the mayor shall immediately nominate another person. The nominees shall be chosen from a list as provided by the State Statutes. Additional inspectors shall be likewise nominated by the mayor for those voting districts for which it may be deemed necessary. For a vacancy caused by sickness, or any other reason, the city clerk shall appoint a substitute which shall be in effect for that day only.

#### 4.03 POLLS.

Polling places shall be as set by resolution of the Common Council. (MC #1213)

#### 4.04 POLL HOURS.

The polls at any election shall be open from 7:00 a.m. to 8:00 p.m., as provided by Section 6.78, Wisconsin State Statutes.
