A RESOLUTION REJECTING THE REPURCHASE OF PROPERTY IN THE WEST SIDE INDUSTRIAL PARK

WHEREAS, BNWC Properties, Inc. has received a binding offer to purchase real estate it owns in the West Side Industrial Park, said real estate legally described as:

Lot 2 of Wood County Certified Survey Map No. 11199, recorded in Vol. 42 of Certified Survey Maps on Page 99 as Document No. 2022R10278; being part of Lot 1 of Wood County Certified Survey Map No. 7005 in the SW 1/4 of the NE 1/4 of Section 12, Township 22 North, Range 5 East, in the City of Wisconsin Rapids, Wood County, Wisconsin.

Tax Parcel No. 3400751A

WHEREAS, the West Side Industrial Park contains a Declaration of Restrictions which allows the City 90 days after notification to accept or reject the City's repurchase rights to land in said Park before the land is sold to another party; and

WHEREAS, BNWC Properties, Inc. has notified the City of its intention to sell to a bona fide purchaser and has requested that the City accept or reject the City's right to repurchase; and

WHEREAS, it is in the best interests of the City to reject the City's right to repurchase;

BE IT RESOLVED, by the Wisconsin Rapids Common Council, as follows:

- 1. That the City hereby rejects and releases its repurchase rights and the City shall have no further interest in the property, and BNWC Properties, Inc. is free to sell the property to a third party.
- 2. The Mayor, City Clerk, and City Attorney are authorized and directed to take such steps as are lawful and necessary in furtherance thereof.

The Parks & Recreation Commission met on Monday, April 10, 2023, at 4 p.m. in the first floor conference room at City Hall, 444 West Grand Avenue, Wisconsin Rapids, WI. The meeting was also streamed LIVE on the City of Wisconsin Rapids Facebook page.

1. Call to order.

Commissioner Broeren called the meeting to order at 4 p.m.

Kris Barteck, Mayor Blaser, Craig Broeren, Tom Ekelin, Tom Rayome, Lee Thao were in attendance. Patrick Gatterman, Carolynn Martin, and Dean Veneman were excused. Staff present were Dawn Desorcy and Jake Klingforth. Also attending were Alderperson Dennis Polach and Diane Passineau.

2. Approve February 13, 2023, meeting minutes.

4. Update on Dog Park.

We received three (3) bids for the fence; Finance & Property Committee will finalize the selection at their next meeting. Work remaining at the park includes grinding, pulverizing, and then seeding. We hope to open in September to allow the grass to get established.

5. Update on Prairie Dog Exhibit.

The original plan must be modified (the exhibit will be slightly smaller) due to the water table in that area. The location is between the camel pen and the fox pen. We are waiting for the crawl tunnel to be delivered. We will be getting 8 prairie dogs. We hope to open the exhibit when the Zoo opens for the season; this will depend on when the glass is ready.

6. Update on Legacy Grant Application.

This application is a collaborative request between the City and Wisconsin Rapids Public Schools, with plans to develop the Mead Park area into an extensive recreational area which will include new play structures, basketball courts, pickleball courts, and an expanded picnic area. If we are awarded this grant, the Commission will need to make a financial commitment at a future meeting. At this point, a timeline is not confirmed.
