The Finance and Property Committee met at 5:00 p.m. on Tuesday, December 3, 2024, in the Council Chambers at City Hall. All members of the Finance and Property Committee were present with Alderperson Veneman via Zoom.

Call to Order

Chairperson Cattanach called the meeting to order at 5:00 p.m.

2. Consider for approval a request from ecoATM, Sean Flaherty, agent, located at 951 West Grand Avenue for renewal of a Secondhand Article Dealer License

6. Audit of the bills

It was moved by Cattanach, seconded by Veneman to approve check no. 23843 to 24051 in the amount of \$2,316,675.74. Motion carried, 3-0.
