The Public Works Committee met at 6:00 p.m. on Tuesday, October 1, 2019, in the first floor conference room at City Hall. Thaddeus Kubisiak, Tom Rayome, and Vernon Verjinsky were present. Others attending are on file in the Clerk's office.

1. Call to order

The meeting was called to order at 6:00 pm

2. Review and consider approving a surveillance camera for the Wisconsin Rapids skate park

Motion by Kubisiak, second by Rayome to refer this item to the Park and Recreation Commission. Motion carried (3-0)

3. Review and consider approving storm sewer options for 21st Place

Motion by Verjinsky, second by Kubisiak to postpone this item until the next regularly scheduled Public Works Committee meeting. Motion carried (3-0)

4. Review and consider approving changes to the lawn mowing practices and procedure on the city owned boulevard, at the south side of the Expressway, between Lincoln Street and 1st Street South

Motion by Verjinsky, second by Kubisiak to request Mayor Vruwink to see if Airport Commission mower can safely be used to mow the Expressway hill. Motion carried (3-0)

5. Review and update of the creation of an ad-hoc committee to oversee a citizen sponsored tree replacement initiative for Robinson Park and other areas in the city, from the aftermath of the catastrophic storm that occurred last July.

Motion by Kubisiak, second by Verjinsky to postpone this item until the next regularly scheduled Public Works Committee meeting. Motion carried (3-0)

6. Review and consider approving a program to pickup large garbage items that do not fit within the totes

7. Review and consider approving a change to the sidewalk assessment levied against property owners

8. Review and consider a change order request to install pour-in-place fall protection for the swing set area at the aquatic park and playground
