Delinquent notices will be mailed after each installment due date.

Drop Box

All the principles of paying by mail apply. City Drop box is located in front of City Hall by the Police Department, and is emptied each morning by the Police Department personnel.

Payments in drop box after 4:30 on grace period due date will be receipted per the Statute.

Payments deposited in the drop box through, December 31, at 4:30 p.m. are receipted as 2017 payments. Payments after December 31, are receipted as 2018 payments. (see back for grace period details)

Mail

January 31, April 30 and July 31 postmarked payments (official due dates) are receipted based on **postmark** and will include the grace period (see back for grace period details) allowed by State Statutes. All other mailed payments are receipted based on **date received** at City Hall.

Pay with Escrow check: less than \$20, immediately; more than \$20, refund check, 7 days Pay with Personal check or M/O: less than \$20, immediately; more than \$20, refund check in 7 days The Wisconsin Department of Revenue (DOR) would like to provide additional guidance related to property tax payment deadlines and the application of the 5 working-day grace period.

Items to Note

- If a property tax payment due date falls on a Sunday or legal holiday, the due date becomes the next business day (sec. 990.001(4)(b), Wis. Stats.)
- If a property tax payment due date falls on a Saturday, unless the municipality or county has official Saturday office hours, the due date becomes the next business day (sec. 990.001(4)(c), Wis. Stats.)
- Property tax payments received within 5 working days after the due date are not delinquent (see the grace period statutes of secs. 74.11 (7) and (8), 74.12 (7) and (8), 74.69(1), Wis. Stats., which are construed as a whole)

This table shows due dates and 5 working-day grace period. Please note if you are paying your taxes in December, there is no grace period for December 31st.
