NOTICE OF MEETING

Please be advised that City of Wisconsin Rapids Mayor Shane E. Blaser will be hosting an Urban Group meeting on **Wednesday, September 27, 2023, at 1 p.m.** in the 1st Floor Conference room at City Hall, 444 West Grand Avenue, Wisconsin Rapids. The purpose of this meeting will be to discuss the funding for the 2024-2029 STP Urban Program. This meeting will allow members of the Urban Group to propose, discuss, and prioritize projects. An explanation of what the Urban Group is follows:

The Wisconsin Rapids Urban Group is composed of municipalities located within the urban area located around the City of Wisconsin Rapids as determined by the Wis. DOT utilizing Federal Highway Administration guidelines. This group is composed of the City of Wisconsin Rapids, City of Nekoosa, the Village of Port Edwards, Wood County, Portage County, the Town of Grand Rapids, the Town of Port Edwards, and the Town of Seneca. The Urban Group receives a funding entitlement from the FHWA administered by the Wis. DOT entitled Surface Transportation Program or STP Urban Program. This program provides federal funding for a wide range of transportation-related activities, including projects on higher function local roads not on the State Trunk Highway system, and local safety improvements. The program is funded through the two-year Moving Ahead for Progress in the 21st Century Transportation Act (MAP-21).
