- > Attended the Village of Biron's monthly meeting to present their emergency first responders with their Mission Lifeline Award
- > All three crews completed building construction review training
- All three crews went through skills training on ice rescue scenarios
- Ropes and knots review
- > One member is attending a fire inspection classes through MSTC to certify at that level
- All members began their annual hazmat physicals
- > Five Bugles Design at the stations to begin next phase of the fire station renovation process
- Continued to provided patient monitoring at the Wood County Health Department vaccination clinics
- Provided EMS standby for WAA state hockey tournament at SWC
- > Structure fire at 251 9th Ave No. resulting in moderate damage to second floor
- > Structure fire at 1030 1st St No. resulting in extreme damage to second floor, smoke and water damage throughout. The Red Cross is assisting the five displaced tenants. Temperatures were 15 below which made firefighting difficult
- > Vehicle fire at 2330 Kingston Rd. Vehicle is listed as a total loss
- > Provided automatic aid to Biron Fire Department for a coal dust fire in a wall of storage room at Nine Dragons
- Cooking fire at 1321 Chestnut, no structural damage. Crews ventilated home
- > Structure fire at 1930 Wylie, Rainbow Coin Laundry. Crew extinguished fire, which was contained to a bank of dryers. Building was ventilated
- > Structure fire at 491 Two Mile Ave. Resident returned to a smoke filled home. Crews found fire in walls in the basement. Fire extinguished and home was ventilated
- > Responded to eight motor vehicle accidents resulting in five injuries
