WRFD meetings, events, training, and notable calls for the month of December:

- Structure fire at 710 11<sup>th</sup> Ave No., fire was located on an outside porch. The home received fire damage to siding and decking. Quick actions by neighbors and WRPD prevented the fire from spreading into the home
- Mutual Aid given to Port Edwards FD for structure fire at 121 Adams Avenue, WRFD EMS transported one burn patient
- Mutual Aid given to Port Edwards FD for structure fire at 1510 Port Road
- Responded to two fires in the dryer system at 2721 Industrial Street. Fires were contained to the drying system with no structural damage to the building or other equipment
- > Responded to 7 motor vehicle accidents with three injury transports and one extrication

### WRFD Updates:

On December 10-11, the Commission on Accreditation of Ambulance Services (CAAS) conducted an on-site review on all aspects of the departments EMS operations. The site review found zero deficiencies and the Commission Panel has awarded the WRFD full accreditation status for the next three years. This was the fourth time the department has went through the accreditation process and the first time we have not had any deficiencies to correct. I believe this is a testament to the department's organizational restructure in 2019 that has brought the operational efficiency that it was intended to bring, but more importantly, it shows the quality of work the members on the department deliver to the community every day.

2020 marked the 100-year anniversary of the WRFD. The year ended with the department responding to 3,976 calls for service, 21 more than 2019 and once again the most in department history. An annual summary will provide a review of the year in detail.
