- 1. Call for Nomination of Chairperson Pro Tem: A motion was made by David Yonkovich and seconded by Tammy Steward to nominate Peter Jennings as Chairperson Pro Tem. Motion Carried.
- 2. Nominations and Election of Chairperson: A motion was made by Joe Terry and seconded by Lee Albrecht, to nominate David Laspa as Chairperson. A second motion was made by Lee Albrecht and seconded by Tammy Steward to nominate Peter Jennings as Chairperson. Lee Albrecht made a motion to close nominations, and it was seconded by Joe Terry.
